- Pursues projects to advance gas transmission eg. Micro-generation





#### Demand Drivers


- Increasing demand in eastern states

- Innovative uses of natural gas, ie. NGV, Air conditioning, Micro-generation


## **Industry Regulation**

- Energy supply equation variables
  - Excessive costs and processing times of regulation
  - Inconsistency of decisions
  - Multi-jurisdictions
  - Discretion
  - Limited appeal rights
  - Existing contracts

## **National Gas Supply Solution**

- Linking Darwin, Mt Isa, Townsville, Gladstone and connecting with existing systems to supply south eastern states
- ▶ 4500km, est. \$2.4B
- Staged implementation
- Can access Timor Sea or PNG





## Benefits to NT Gas Pipeline

- Staged approach sees benefit from Darwin to Mataranka or Daly Waters
- Mataranka to Gove pipeline can operate at 10MPa
- New pipelines can operate in parallel at 10MPa or independently at 15MPa
